Palliser School Division

Technology Annual Report 2022-2023 School Year

The Palliser School Division Technology Services Department is focused on providing students and staff with the tools needed to ensure high-quality learning environments. There is an ongoing focus on utilizing technology that is device agnostic and is hosted in the Cloud. The Technology Services Department continues to strive to meet new hybrid learning spaces to ensure the continuity of learning and operations. Increasing equipment and service costs have created some challenges for the Department, but Technology Services has met learning needs and demands adequately over the last year.

- 1,000 student Chromebooks deployed (evergreening to maintain 2:1 ratio)
- Staff evergreening continued with shift to Chromebooks
- 100 Interactive Board upgrades
- 390 iOS devices registered in JAMF
- 13,505 instances of APPS for staff and students
- 1 summer student to be hired to support the evergreening and Chromebook deployment
- Implementation of Edsembli commenced
- Added Help Desk position
- Integrated National Sports School to the Network
- Hired the technology Supervisor
- Evergreening of wireless network completed
- Continued move to VOIP phone system
- Continued security camera system upgrade

Innovation

Palliser continues the migration to Cloud Computing and the digitization of content in both education and operations. With our Help Desk firmly in place, we have made great strides in improving our inventory management and have increased our ability to make strategic decisions regarding changes to the technology used in our classrooms. We continue to work with schools that want to engage their community in providing technology at a 1:1 ratio (we piloted a 1:1 initiative at RI Baker to evaluate the impacts of increased availability of devices for students). We continue to migrate staff to Chrome devices from Windows devices to decrease total cost of ownership and recognize efficiencies in classroom technology design (docking stations to allow for flexibility vs stationary desktops). ViewSonic ViewBoards have been installed in 5 of our schools and Central office as a test replacement of Epson projectors. ViewBoards will allow Palliser to extend the life of classroom displays by at least 5 years with no material replacement costs (bulbs, interactive pens, etc).





Large Scale projects

Edsembli and Edsby Going “Live”

Palliser retired its former SIS, PowerSchool, in August 2022 and replaced it with Edsembli. There were numerous challenges the department faced in getting the service functional for schools. Issues of note were the integration of third party applications such as Dossier and School Messenger, getting PASI working correctly to sync student records and enrollments and registration form issues. Through the diligent efforts of Mike Auger (Systems Analyst), Sherryl Loman (SIS Coordinator), and our school Administrative Assistants, Edsembli is now functional. There are still some system issues that we are working with Edsembli to resolve, but all hopes point to a smoother startup next September.

Edsby, our new Learning Management System, is now in place and we are finalizing the integrations between it and Edsembli. Initial plans were to only roll this out to our K-6 schools but we have since extended this to K-12 due to demand.

Expansion of the National Sports School

The National Sports School expanded resulting in 7 new classrooms and a collaborative learning space.

Supernet 2.0 Migration

Palliser completed its migration to Supernet 2.0 in August 2022. This migration will allow Palliser to take advantage of increased bandwidth offerings from the Alberta Supernet in the future. The Supernet service catalog has also been expanded and streamlined to limit the time investment required to make required network changes to provide services to schools.

Cyber Security Initiatives

With the threat of cyber attacks increasing, Palliser has undergone significant improvements to its cyber security practices.





Implementation of Carbon Black (Endpoint Detection and Response - EDR) and Backupify

To comply with Cyber Insurance requirements, Palliser has purchased an EDR solution called Carbon Black. An EDR is an endpoint security solution that continuously monitors end-user devices to detect and respond to cyber threats like ransomware and malware. This software is currently protecting all Windows and MacOS devices in the Division. Chromebooks do not require this protection as ChromeOS has a lower attack vector for bad actors to leverage. This is another reason we are encouraging users to move to ChromeOS devices.

Palliser has also implemented a cloud hosted backup solution, Backupify. Backupify will create backups of all staff Google account assets (GMail, Drive, Shared Drives, etc). Having this solution in place should allow Palliser to recover in the event of a disastrous attack that may compromise the system.

Safeguarding Palliser's Network with MFA (Multi Factor Authentication)

Again, to comply with Cyber Insurance requirements, Technology has implemented MFA for all privileged access to Palliser's server environment. All access to sensitive areas of the network infrastructure is now protected. Palliser has also implemented MFA for all Palliser staff Google accounts. This extra step in authentication is a huge step in hardening Palliser's network from would-be attackers.

On the Horizon...

Technology is looking to further increase its Cyber Security posturing by working inside of the [NIST Cyber Security framework](#) and developing governing processes for technology practices in the division (Cyber Security Incident Response, Password Security, etc). Palliser will also be revisiting its Phishing education tools and Cyber Security training initiatives. We are also looking at the software offerings currently in use in the Division to ensure that access is protected with MFA.

Wireless network upgrades

Updates to the firmware of Palliser APs has resulted in Palliser being set up for wifi 6e - future proofing the wireless network.

Voice of Internet Protocol (VoIP)

We have completed installing VoIP phone systems in Palliser-owned buildings. We are starting to realize workflow and efficiencies as a result of this upgrade. We are currently working closely with facilities to integrate the new phone systems with the PA systems (Sunnyside School, RI Baker, JEES and Coalhurst High have been completed - County Central is currently being worked on). This much-needed modernization has upgraded outdated equipment and we are working with Facilities to eliminate other analog lines purchased from Telus to further increase cost savings for the Division.
