

ALBERTA SCHOOL BOARDS ASSOCIATION (ASBA) ZONE 6 UPDATE APRIL 17, 2024

ASBA Reports:

Review of the 2023-2026 Strategic Plan:

Identified the three Main Goals to remind us what direction the ASBA is to be heading. Summarized the Services provided by ASBA. Advocacy, Profession Development, Zone Supports, award, Francophone, Indigenous, Representation,

Communications/Administration/Governance. There are three additional services provided at a cost; Consulting services, Trustee Governance program, General meeting registration.

- Expenses: Consulting fees will be reduced to 225/hr from 250/hr. Hopefully we will see a greater increase in use.
- Membership fees have increased by 4%.
- Discussed the practicality of the Board Chair Engagement Sessions. Will be moving ahead with these. Will try and get more information out to Chairs as is possible.
- (Innovation of Artificial Intelligence is a new committee and will run for another year IAI).
- By increasing membership fees over time, and slowly decreasing our use of reserves, this will hopefully allow us to become sustainable based on fees alone within three years.
- Discussion concerning the amount of reserves ASBA currently has occurred. The
 amount of reserves given by ASBA is the amount recommended by their auditors. They
 are considered a nonprofit organization and so there are no government restrictions on
 the amount of reserves they can carry.
- (The FAGM and SAGM will not be offered in a Hybrid format to try and cut cost to host these meetings)

President's Report - ASBA Board of Directors:

- Asked the minister to look into the suspension of CTS education at the University of Lethbridge. He will see what is happening as the Province is very much behind CTS education.
- Discussed with the Minister the promotion of CTS. Look at the April 11 update sent to Chairs.
- Bill 18 discussion. Will continue to monitor. (Funding for Federal Programs)
- Dual credit grants. May 3 to apply for these. (Two Grants)
- The Federal Government announced the National school nutrition program. Funding has been announced.
- If our Division has a request concerning budget problems and sends that to the Province. Please send a copy to the ASBA as well so they can see if there is a common theme associated with these.





- Bill 13 concerns. Will continue to look into this to ensure that Boards are able to do what is best for them with respect to properties in their division.
- IAI meetings are starting to move ahead.

Q/A Concerns with respect to the last budget and lack of funding for several areas. Not new concerns and these are on the list to be addressed.

Vice-President's Report - ASBA Board of Directors:

- 3-6pm engagement session with Ministers at the SAGM. Please consider attending.
- Policy Position meetings with Ministers concerning the party politics suggestions with Municipal elections.
- Trying to stay on top of the latest Bills that have been proposed and advocating on our behalf.
- Three new committees have been established to look into current issues.
- Ongoing efforts to meet with Ministers. These have been difficult to set for some Ministers.

Q/A Concerns trying to get Carbon Tax information to the Minister of Education in the short timeline.

Chief Executive Officer's Report:

- Parental Rights trying to make sure that there is representation from all areas of the province and rural and urban areas.
- Review of deadlines that are upcoming.
- Enrollment challenges and adequate funding.
- ASEBP replay of session with them.

Zone Director Report:

- Honoring Spirit awards- Very impressive.
- Careers and the Germanic model this will be posted later
- April 4 the Budget for ASBA was sent out. Please discuss these at your local board meetings coming up.

Zone 6 Chair Report:

- Edwin Parr award planning is going well. Interviews are upcoming.
- Zone Banking report is available to allow us to follow up at our Board meetings. (These questions and responses will be sent out)

Labour Relations:

 Because there is no specific funding provided for staffing in the latest budget and because this is a problem we all face. Certificated staff raise was funded but not support staff. In times past when funding was given for teachers support staff was included in those increases. Last year was the first time the support staff wasn't included. The





Minister suggested that the support staff funding was included in the classroom complexity grant. We need to voice our concerns and outline our own unique items. This is to be done at the divisional level.
