



Background

The Board reviews and revises its policies on a rotational basis which provides for all policies being reviewed at least once per term of office.

At the December 10, 2024, Regular Meeting of the Board, the Board directed Administration to share amended drafts of <u>Policy 3: Role of the Trustee</u>, <u>Board Chair</u> and <u>Policy 9: Appeals and Hearings Regarding Teacher Transfers</u>, formerly Policy 9: Appeals and Hearings Regarding Teacher Matters, for stakeholder information. Following a period of stakeholder review, the Policy Committee will bring forward these two policies for final approval.

At the Policy Committee meeting in November, the committee planned to meet in March but due to the ongoing Superintendent search, the Board directed the committee to meet in early January. The Policy Committee met on January 7, 2025, and reviewed Policy 1: Role of the Board of Trustees and Policy 2: Role of the Superintendent.

The Policy Committee will seek feedback from the Board on Policy 1: Role of the Board of Trustees.

RE: Bill 27 Administrative Procedures

Background

Bill 27 passed in the legislature and received Royal Assent on December 5. The bill makes several amendments to the Education Act including sections involving gender identity, sexual orientation and human sexuality, as well as amendments to ensure education continuity during public health and states of emergencies.

The division has reviewed and updated current administrative procedures (APs) to align with the amendments.
