HIGHLIGHTS

Planning and preparation for community engagement sessions for the Board's strategic planning project have continued. Habits of Mind conversations with School Administrators continue to guide and develop dispositions in our division's leaders. Administrative procedure review is ensuring compliance with pending changes to the *Education Act* and a professional development session reviewed pending changes to privacy and access to information legislation. A review of the 2023-2024 Annual Education Results Report with Alberta Education highlighted the ways the division is enabling the success of students and highlighted strategies to promote continuous improvement in meeting students' needs. Key activities this month included a series of school visits, regular Senior Administrative Team meetings, the monthly Administrators Council meeting and attendance at the CASSIX conference, which offered opportunities for professional development and discussion with school divisions in the southern part of the province. Participation in the Canadian Association of Public Schools-International (CAPS-I) trade mission to Turkey provided the opportunity to continue building long-lasting partnerships with agencies focused on international student education.
