#### HIGHLIGHTS

The Board of Trustees and Senior Administration met for two days of strategic planning with Incite, a consulting agency. The group reviewed feedback data from Division stakeholders to create the Board's long-term strategic plan, which will be reviewed at the next Board Meeting. The Superintendent's student advisory group met at Calgary Christian Secondary School where students from Palliser's Calgary schools met to discuss highlights from the recent student survey. The students had powerful insights and ideas to share. Habits of Mind conversations with School Administrators are continuing throughout the school year, increasing awareness and understanding of different thinking styles and approaches to learning and problem-solving. Administrative procedure review continues to ensure legal compliance and alignment with Board policies and objectives. External engagements this month included attending the College of Alberta School Superintendents (CASS) Annual Learning Conference. Regular Senior Administrative Team meetings, the monthly Administrators Council meeting and school visits took place.

AREAS OF EMPHASIS FOR NEXT MONTH

Next month will see a continued focus on the Habits of Mind conversations with School Administrators, further administrative procedure review and school visits. Work will continue with Board strategic planning with the Board scheduled to review the plan at their May Meeting. South Zone schools will meet with the Superintendent in mid-April, Following that meeting, a summary report and action plan to incorporate the student feedback into the future vision of the Division will be developed. Scheduled external engagements include the Teachers' Employer Bargaining Association Monthly Engagement Session and attending the College of Alberta School Superintendents FNMI Gathering.


#### AREAS OF EMPHASIS FOR NEXT MONTH
